RTD to Hold Public Hearings on Proposed Service Modifications That Would Take Effect in July

(Stockton, CA) – San Joaquin Regional Transit District (RTD) has scheduled eight (8) public hearings to invite public comments on the proposed July 2011 Service Modifications. These proposed service modifications are the result of decreased transit funding and increased operating costs, including fuel, anticipated in Fiscal Year 2012, and include the modification of weekday service, restructuring of weekend service, and significant modification and restructuring of Commuter services.
