ATTENTION: INTERREGIONAL (COMMUTER) CUSTOMERS

San Joaquin Regional Transit District (RTD) has scheduled seven (7) public hearings (four in Stockton, one each in Lodi, Manteca, and Tracy) to invite public comments on proposed Interregional (Commuter) route consolidations and a fare increase, in addition to service reductions in the Stockton Metropolitan Area (SMA). The public hearing schedule is provided at the back of this notice. If approved by RTD's Board of Directors, these changes would be effective August 2010.

RTD is facing a serious reduction in available revenues due to State transit funding cuts. As a result, RTD must identify ways to increase revenue and decrease costs. RTD staff reviewed ridership and service effectiveness on all routes and services to identify cost saving opportunities based on ridership, available parallel capacity, and funding resources.

RTD is proposing to combine routes 153 into 151 and Route 154 into 152, to create redesigned Routes 151 and 152, and add a Tracy stop to Route 167 effective August 2010. RTD is also proposing to increase fares on all Commuter routes by three percent (3%). Based upon previous commuter customer feedback, RTD staff is proposing regular, modest fare increases rather than infrequent, larger fare increases. Since 2001, RTD has raised commuter fares only once (in 2008).
